

## **EcoMint Ltd - Privacy Policy - updated on 10 September 2022**

We know that you care how information about you is used and shared and we appreciate your trust in us to do that carefully and sensibly. This privacy notice is to help you understand how we collect your personal data and what we do with it.

When we refer to “we”, “us”, and “our”, we mean EcoMint Ltd (a company registered in England under registered number 13700952) with registered address at 1 Lower Velwell, Dartington, Totnes TQ9 6AD. Our trading name is “Angry Teenagers” and our website is [www.angryteenagers.xyz](http://www.angryteenagers.xyz).

We are the data controller of the personal data collected about you.

By “you” or “your” we mean any individual, sole trader and/ or partnership that gets products or services from us, uses our website, or interacts with us in another way.

If you have any questions, comments, or concerns about this privacy notice, please contact our Data Protection Officer whose details are in section 16 below.

### **1. Scope of this Privacy Notice**

This privacy notice sets out the way in which your information you provide to us, and information about you collected by us, is handled, stored and processed.

### **2. Where do we get your information from?**

Your information may come to us from different sources:

- Directly from you when you purchase products from us, submit information via our websites, complete forms we provide to you, enter our competitions and promotions, exercise your statutory rights, or otherwise contact us.
- Information you submit to our social media accounts.
- Our Website may collect information about how you use it.

### **3. What sort of information do we obtain?**

We collect the following types of information:

- Name and address
- Email address
- Wallet address
- Proof of identity / address documentation
- Credit card information
- Technical data via cookies (see our cookies section below):

- Exercising your rights: if you exercise any of your statutory rights under data protection law, we will keep a record of this and how we respond.

#### **4. How we use your information**

Some of your information is stored by us while other information is collected and passed to our third-party providers and not stored by us.

##### **How information that we store about you is used:**

###### **Name and email address:**

If you provide your name and email address at time of purchase, we will use your email address to keep you informed of the project votes in which you have the right to participate as an Angry Teenager token-holder.

If you contact us we will use your email address to provide a response.

The lawful basis for both these cases is consent.

###### **Technical data via cookies:**

We use your information to operate, provide and improve the services we offer you.

We may also aggregate information and generate statistics for the purposes of measuring the functionality and features of our services.

The lawful basis for collection of technical data is both consent when it is sought for use of cookies and legitimate interests in running our organisation effectively when ensuring our systems are working effectively and user issues can be resolved.

##### **How information that we collect, but do not store, about you is used:**

Wallet address, address, proof of identity / address documentation and credit card information are collected for the purpose of purchasing your Angry Teenager early-bird token. Our third-party provider, Wert (trading name of SHA2 solutions OÜ), provides the payment transaction and therefore the data you input is passed to them for payment processing. Wert's privacy policy is here: <https://widget.wert.io/privacy-policy>. Please ensure you read it carefully.

The lawful basis for collecting this data is because of our contract with you.

#### **5. Does EcoMint Ltd have to use my information?**

We process your information to be able to provide you with your token purchase. Without your information we wouldn't be able to do this, we use the minimum amount of information we need to enact the transaction.

Where you have asked us to keep you informed of the project votes in which you have the right to participate as an Angry Teenager token-holder, you can ask us to stop sending you this information and we will remove your name from our contact lists. Please let us know if you would like to do this using the contact details in section 16 below or via the unsubscribe options on the communications you receive.

## **5. When we might disclose your information**

We may share your information with third parties to perform services on your behalf. The third parties who may have access to your information include:

- Our payment processing provider, Wert. Wert's privacy policy is here: <https://widget.wert.io/privacy-policy>.

We may also disclose your information to the extent that we are required to do by law.

We will never sell or share your information with other organisations for their direct marketing purposes.

## **7. How long we keep your information for**

Information that we process for any purpose will not be kept for longer than is necessary for that purpose. Different purposes will have different retention periods and we will retain your information:

- For the duration of the project to which your Angry Teenager token is tied.
- To the extent that we are required to do so by law.
- To support our ongoing business purposes (with due consideration for the rights and freedoms of individuals privacy).

We will not retain your wallet address, address, proof of identity / address documentation or credit card details.

## **8. Your rights**

You have a number of rights under data protection law including:

- The right to be informed about the collection and use of your personal data e.g. via this privacy notice.
- The right to access your personal data.
- The right to have any inaccurate personal data rectified, or completed if it is incomplete.
- The right to have your personal data erased in certain circumstances.

- The right to request the restriction or suppression of your personal data in certain circumstances.
- The right to data portability - to obtain and reuse your personal data for your own purposes across different services.
- The right to object to our use of your information in certain circumstances e.g. for marketing or profiling purposes.

If you would like to access your own information or exercise any of the rights detailed above, please contact us using the details in section 16 below. If any of your details change, you can contact us and we will make the necessary updates.

In the majority of cases, we will respond to your request within one month of receiving the necessary information required to deal with your request.

### **Can I object to your use of my information?**

You can withdraw your consent for use of your information to keep you informed of the project votes in which you have the right to participate as an Angry Teenager token-holder by unsubscribing. On all communications provided by us we will provide you with details on how to withdraw your consent to the continued receipt of communications.

### **How do I raise a concern if my rights are not met?**

## **9. How do we use cookies and other information gathering technology?**

We collect certain information automatically through the use of "cookies." A cookie is a small file of letters and numbers that we put on your device (smart phone, tablet, computer) if you agree when you access our app or website via the same device.

We use various types of cookies, including session cookies which improve your internet browsing experience and analytical cookies. We use analytical cookies to enable us to recognise and count the number of visitors to our website and app and to see how visitors

move around our website and app. This is used to help make our websites and apps easier to use.

### **Information collected**

Our cookies collect information about your device behaviour such as usage and location data. We do not use cookies to collect or record information on your name, address or other contact details.

### **What are cookies used for?**

The main purposes for which cookies are used is:

- For technical purposes essential to effective operation of our application, and website particularly in relation to user experience.
- To improve the way our website and apps works, for example by ensuring that customers are finding what they are looking for easily.
- To enable us to collect information about your device behaviours.

We will never sell any of the information we collect about you to any third party.

### **How do I disable cookies?**

You will be provided with the option to accept the use of cookies when you access our website and apps. If you do not accept the use of cookies then we will not be able to provide you with tailored content and offers to the same level as we can when the cookies are enabled, and some parts of our website and app may become inaccessible or not function properly.

## **10. Profiling**

Data protection law includes certain provisions around how information can be used for:

- Profiling – where information is processed to evaluate certain things about an individual.
- Automated individual decision making – where a decision is made based on your information solely by automated means.

This includes ensuring that individuals are made aware of profiling and or decision making, how decisions are made based on this and the consequences of these decisions.

We do not carry out any profiling or automated individual decision making about individuals.

## **11. Transferring information outside the UK or European Economic Area**

We may transfer information that we collect from you to third party data processors or service providers located in countries that are outside of the UK or EEA (the European

Economic Area) in connection with the purposes for which we have collected it from you. If we transfer your information outside the UK or EEA we will only do so where one of the following applies:

- There is an adequacy decision by the European Commission which means that the recipient country is deemed to provide adequate protection for such personal data.
- Where we have in place standard model contractual clauses (which include certain safeguards to protection information) with the recipient which have been approved by the European Commission.
- If such transfer is needed to enable us to perform our contractual obligations to you relating to products or services we have agreed to provide to you.

## **12. Security of your Information**

We are committed to taking all reasonable steps to protect your information, including the use of appropriate technical and organisational controls to ensure your information is stored, accessed and shared appropriately. Our people are trained in the appropriate management of confidential information and our website and apps have been security tested to ensure the safe sharing of your information with us. All our procedures will be reviewed routinely and updated to ensure they continue to protect your information effectively in line with advances in technology and data protection law.

## **13. Third party sites and apps**

Our website may contain links to other websites and apps operated by third parties. Please note that we cannot be and are not responsible for information that third parties may collect, store and use through their websites and apps. You should always read carefully the policy of each website and app you visit.

## **14. Different formats of this privacy notice**

The information provided within this privacy notice can be made available in different formats including in printed form, and methods that meets the needs of the visually and hearing impaired.

## **15. Changes to our privacy notice**

This privacy notice will be reviewed regularly , should any new types of processing be identified or changes to data protection law mean changes are required.
